REPORTS

COMMITTEEPERSON PETERSEN

Committeeman Petersen reported that he had meet with representatives of Warren County Soils, NRCS, Ferriero Engineering and SESI Consulting Engineers (geo-technicians) on 18 January 2012. In conclusion it was agreed that the geo-technician would prepare a quote for core testing in the landslide area to establish the depth of sand above bedrock for determining a piping schematic for remediation.

MAYOR INSCHO

Mayor Inscho read a letter from Shannon Scaaf expressing her appreciation of the residents and township committee support during the events of 2011.

MUNICIPAL ENGINEER

Paul Ferriero, Municipal Engineer, reported that he is working with Garth Hawkins, FEMA Representative, for potential Lewis Lane reimbursement. He stated that FEMA has committed to participate in various programs of repair and remediation within the Liberty Township mudslide area.

MUNICIPAL COURT OF NORTH WARREN

A letter of 17 January 2012 was received from Mary Pat Quinn, Municipal Clerk Township of Hope, providing an analysis of the Municipal Court of North Warren at Hope which was prepared by Anthony Ardito, RMA. Documentation provided reported that the Liberty Township total 2011 cost was \$4,087.77 and a total 2012 projected annual cost would be \$1,364.35 at an annual cost savings of \$2,723.43. Mayor Inscho reported that he would continue to monitor the merger with Timothy McDonough, Mayor of Hope Township.

Mayor Inscho reported that the 2012 Annual Residential Cleanup with be conducted the week of 7-12 May 2012 and a second session conducted 15-20 October 2012.

HILLSIDE AVENUE LOT LINE ADJUSTMENT, BLOCK 49, LOT 1

A letter of 23 January 2012 was received from Ethan and Barbara Hashagen requesting the refund of the \$750 escrow posted for the lot line adjustment between Block 7, Lot 50 (Randazzo) and Block 49, Lot 1 (Hashagen). The refund request was made by Mr/Mrs Hashagen due to the fact that the application had been pulled by Mr Randazzo. Following discussion, it was agreed that Attorney Skoog would forward a letter to Mr/Mrs Hashagen indicating that the escrow funds had been used for initial investigation work by the municipal professionals and there are no escrow funds available for refund.

FREE UNION UNITED METHODIST CHURCH

A request was received from Pastor Jim Craig on 25 January 2012 for the Township Committee's consideration to waive the inspection fees affiliated with the installation of the new wood stove in the church building. A motion by Dan Grover to waive the fees affiliated with the installation of the wood stove for the Free Union United Methodist Church carried. Mayor Inscho and Ron Petersen abstained.

12 LEWIS LANE

A letter of 24 January 2012 was received from Alice Bechok questioning the feasibility of reconstructing a structure on the property as well as an easement for remediation of the area. Attorney Skoog advised that he is awaiting professional responses to define a repair/remediation location and the potential usability of the property in the future.

2012 BUDGET WORKSHOP

It was agreed to conduct a 2012 Budget Workshop on Thursday, 2 February 2012 at 6:00 pm in the Municipal Building, 349 Mountain Lake Road, Great Meadows. Mayor Inscho stated that the 2012 budget would be paying off a Green Acres loan and contains a total debt of \$19,000.00.

GREAT MEADOWS REGIONAL BOARD OF EDCUATION

An extract of the 17 January 2012 meeting minutes of the Great Meadows Regional Board of Education was received on 26 January 2012. The extract contains a certified copy of a Resolution to Eliminate the Vote on the Annual Budget and to Move the Election of School Board Members to the General Election in November. The consolidation of the elections would be an approximate cost savings to the Board of Education of several thousand dollars.

PUBLIC COMMENT was opened at 7:28 pm.

Phil Wooldridge – Mr Woolridge thanked the Township Committee for waiving the construction fee for the Free Union United Methodist Church. He announced the following environmental commission schedule activities; amphibian crossing training session, 4 February 2012 and hazardous tree workshop, 10 March 2012 with a snow date of 24 March 2012.

Lisa Thomas – Ms Thomas questioned the status of the Municipal Lodge and proposed some use options.

Lynn Gilmore – Ms Gilmore inquired into the progress of dilapidated structures around Mountain Lake. She was advised that the properties in question remain privately owner and the structure have been red flagged by the construction official.

Ms. Gilmore also questioned cleanup of the 14 Lewis Lane residence and intentions for the Mountain Lake Community Center site following the demolition of the structure. Ms Gilmore was advised that the various professionals are preparing plans and reports to address the situation.

Eileen Heydecke – Ms Heydecke inquired into the Lewis Lane cleanup cost and research expenses. Ron Petersen advised that the Warren County Freeholders had waived some fess for cleanup materials and a FEMA application was in process.

Ms Heydecke also questioned why the township was hiring a new cleaning service. She was advised the previous company did an excellent job and had decreased her work schedule.

At 7:45 pm a motion by Ron Petersen to adopt the following Resolution carried.
