ORDINANCE #2012.002

Following discussion, a motion by Mayor Inscho to introduce Ordinance #2012.002 on First Reading carried. Peter Karcher abstained. Public Hearing and Adoption are scheduled for 2 August 2012.

An Ordinance to provide for Enforcement of the Uniform Construction Code with the Township of Liberty by the New Jersey Department of Community Affairs

Be it Ordained by the Township Committee of the Township of Liberty, in the Country of Warren, State of New Jersey, as follows:

- I. Sections 7.1 through 7.6, inclusive, of Chapter 44 of the Code of the Township of Liberty regarding the function and duties of the Construction Codes, Uniform are hereby repealed, effective upon the assumption of jurisdiction by the State of New Jersey, Department of Community Affairs, as provided below.
- II. The following new provisions of Chapter 44, Uniform Construction Code are hereby established as follows:
- 7.1 State Uniform Construction Code Enforcing Agency

7-1.1 Relinquishment of Jurisdiction.

The Township of Liberty, pursuant to NJS 52.27D-124 and NJAC 5:23-4.3, hereby relinquishes its jurisdiction of the administration and enforcement of the Uniform Construction Code and transfers jurisdiction for the administration and enforcement of the Uniform Construction Code to the Department of Community Affairs for the State of New Jersey. The transfer of jurisdiction pursuant to this section shall not take effect until the expiration of 120 calendar days from the date a certified copy of the Ordinance is forwarded to the Department of Community Affairs or until the Department of Community Affairs shall exercise its jurisdiction to enforce the Uniform Construction Code, whichever is sooner.

7-1.2 Records and Files. The Township of Liberty shall make available to the Department of Community Affairs any and all records and files of the municipality necessary for the Department to out is functions.

- 7-1.3 Construction Code Fees. Fees for service provided for inspections, permits and enforcement of the Uniform Construction Code shall be as established by the Department of Community Affairs, which schedule is adopted by reference.
- III Severability. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- IV Repeale4r. All Ordinances or parts of the Ordinances in consistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency

V Effective date. This Ordinance shall take effect after final passage, adoption and publication according to law
