A special meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 29 November 2012. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:13 p.m.

REPORTS

COMMITTEEPERSON KARCHER

Committeeperson Karcher stated that he would coordinate with Committeeperson Dan Grover to prepare the specifications for a pavilion upon the beachfront property.

COMMITTEEPERSON PETERSEN

Committeeperson Petersen reported on the DPW accomplishments with handling SuperStorm Sandy debris and destruction within Liberty Township. He suggested ComCast Media be contacted to address the many wires remaining upon the ground throughout the municipality.

Committeeperson reported that the paving project upon Lakeside Drives West and North has been completed and awaiting the line striping to complete the project.

Committeeperson Petersen asked that the DPW contact the paving contractor to address a low puddle spot upon Lakeside Drive West, by the former Casino site.

COMMITTEEPERSON FISHER

Committeeperson Fisher commented on the commendable work of Liberty Township DPW and OEM Team having all municipal roads open for emergency and public access within 24 hours.

DEPARTMENT OF PUBLIC WORKS

Steve Romanowitch, CPWM, presented the following verbal report:

- ✓ Denville Line will be scheduled next week to double stripe Lakeside Drives. Lakeside Drives North and West expense will be covered within the NJDOT Grant funds and the municipality will be responsible for the stripe painting upon Lakeside Drives East and South
- ✓ Road right-of-way cleanup and chipping continue on the debris from SuperStorm Sandy.
- ✓ An individual will begin working with the DPW on Monday, 3 December through the Warren County Community Service Program for a term of 180 hours.

MAYOR INSCHO

Mayor Inscho read letters of gratitude and appreciation from the fire company and a resident within the Mountain Lake area regarding the support of the neighborhood to overcome the aftermath of SuperStorm Sandy.

SUPERSTORM SANDY

Mayor Inscho reported that a volunteer rooster was being created in preparedness of future SuperStorms. Mayor Inscho stated that Liberty Township would not be participating in a class action suit against JCP&L regarding their responsiveness to the storm conditions.

Following discussion, the DPW was asked to compose a listing of dangerous trees that remain leaning as a potential danger to motorist and pedestrians upon municipal roads.

His work included insight and knowledge of the area that would become the foundation of this devastated site cleanup.

In addition to his attention paid to major events in the town, Mr. Romanowitch makes outstanding and unique contributions that positively impact the municipality's operations, every day. Always watchful over his Township, Mr. Romanowitch conducts inspections of township roads and properties following storms, community events, and even on Sunday mornings following church services. On patriotic holidays, he personally drives to various municipal sites to raise American flags, returning in the evening hours to lower the flags. He never misses attending a Township Committee Meeting, not only as an employee of the town, but also as a concerned resident. This is all done on his personal time, in his personal vehicle which is a display of his allegiance to Liberty Township.

Ms. Romanowitch's fiscal responsibility cannot be underestimated. He is always conscious of the cost to the Township assuring that every bill is properly processed and addressed promptly. He is happy to save Township money by using and maintaining a 1988 International Dump truck, 1984 Ford dump truck, 1995 Ford F-800 dump truck and a 1997 Ford F-350 mason dump truck.
