# Statement of Legislative Intent

This Ordinance is prepared in order that agriculture, as permitted in the R-1 Zone (Section 105-62 A and B) may also be a permitted use in the B-1, B-2, B-3, I-1 and I-2 Zones. Agriculture is a significant element in the character of the Township, the local economy is undergoing a contraction and it is the intent of the Township Committee to expand the opportunities available to property owners in the Township when this may be accomplished without substantial negative impact on neighborhoods and the character of the Township.

Section 1. Section 105-69A is hereby amended to add "105-69A (14) Agriculture as permitted in the R-1 Zone in Sections 105-62 A and B.

Section 4. Section 105-73 is hereby amended to read "Agriculture and Agricultural business offices".

Section 5. Section 105-75 is hereby amended to add "105-75I. Agriculture as permitted in the R-1 Zone in Sections 105-62 A and B".

Section 105-80 is hereby amended to add "105-80E. Agriculture as permitted in the R-1 Zone in Sections 105-62 A and B".

A Resolution to Affirm the Liberty Township Civil Rights Policy with Respect to all Officials, Appointees, Employees, Prospective Employees, Volunteers, Independent Contractors and Members of the Public that Come into Contact with Municipal Employees, Officials and Volunteers.

WHEREAS, it is the policy of Liberty Township to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act; and

WHEREAS, The Governing Body of Liberty Township has determined that certain procedures need to be established to accomplish this policy; and

*NOW, THEREFORE BE IT ADOPTED* by the Liberty Township Committee that:

- Section 1: No official, employee, appointee or volunteer of the Township by whatever title known, or any entity that is in any way a part of the municipality shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township's business or using the facilities or property of the Township.
- Section 2: The prohibitions and requirements of this Resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the municipality to provide services that otherwise could be performed by the Township.
- Section3: Discrimination, harassment and civil rights shall be defined for purposes of this Resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- Section 4: The Township Committee shall establish in written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this Resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.
- Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.
- Section 6: The Township Committee shall establish written procedures that require all officials, employees, appointees and volunteers of the Township as well as all other entities subject to this Resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this Resolution.
- Section 7: The Township Committee shall establish a system to monitor compliance and will report at least annually to the Mayor the results of the monitoring.
- Section 8: At least annually, the Township Committee shall sauce a summary of this Resolution and the procedures established pursuant to this Resolution to be communicated within the municipality. This communication shall include a statement from the Governing Body expressing its unequivocal commitment to enforce this Resolution. This summary shall also be posted on the Municipal website.
  - Section 9: This Resolution shall take effect immediately.
