

**Liberty Township Recreation Commission**  
**Regular Meeting Minutes**

Chairman Doyle called the meeting to order at 7:04 PM in accordance with the Sunshine Law.

**Minutes** The minutes of May 26, 2010 were approved on a motion by Mr. Scudder, seconded by Mr. Cassini with all in favor. No meeting was held in June.

**Reports**

**Baseball-** Mr. Doyle reported that Mr. Crisafulli is looking into putting together a 4/5<sup>th</sup> grade travel baseball team, not tied to LTRC. They would use our field for practice.

After discussion, Mr. Scudder made a motion to waive the drafting policy for the 2010 season for 1<sup>st</sup> & 2<sup>nd</sup> grades, the Commissioner to form the teams, seconded by Mr. Lindow, all in favor.
