Baseball- Registration will be January 13 & 16. Mr. Spangenburg requested the team names be changed to Great Meadows Baseball. This was referred to the Twp. Committee. Players from Independence are expected because the Colonial Little League has taken over their recreation program. Fees were set at \$70, T-ball \$35, pants and shirts \$14 each on a motion by the Chair, seconded by Ms. Sabo, all in favor.
