Dan Gaeta reported that Sarah Grub shall be the community day coordinator for 2017. She will begin working on the program January 2017.

The potable water test has failed. Discussion ensued on prior knowledge of testing date for line purging; port-a-john vs concession stand water testing costs; concession stand closure 12 November with last games of soccer season.

#### BEACH AREA DEVELOPMENT

Dan Gaeta announced that he has been in communication with Buddy from Easy Docks, and Gwen Fisher, Head Lifeguard, to discuss the beach docks proposals. It was agreed that Dan and Pete Karcher would meet with Buddy at the beach for consideration of installing a free floating dock within the swim area. LTRC would investigate their availability of funds to cover the costs and request additional funding from the Township Committee if necessary for any shortcomings.

Consideration on relocating the boat dock to the left of the boat launch area was discussed to eliminate the creation of stagnant water between the two docks. Pete Karcher advised that Dan Gaeta discuss this suggestion with Dan Grover who has planned the beach-boat launch-pavilion area.

### RECREATION ASSISTANT APPOINTMENT

Following discussion it was agreed that LTRC would propose to the Township Committee the Recreation Assistant salary of \$13.00 per hour with a minimum of three (3) hours and the maximum of ten (10) hours per week.
