Covid-19 Test Scams - Beware

Have you gotten robocalls, text messages, or emails offering COVID-19 tests in exchange for your Medicare Number? **Be careful! Scammers are selling fake and unauthorized at-home COVID-19 test kits** in exchange for your personal or medical information. Do not give out your Medicare Number for COVID-19 test kits!

Make sure to purchase FDA-approved COVID-19 test kits from legitimate providers. Over the counter or at-home tests are available for sale around the U.S. at many reputable and trustworthy retailers and pharmacies. Remember, each household in the U.S. can also have four free COVID-19 at-home tests shipped directly to their home at no cost. **Visit COVIDtests.gov** to order tests or learn more about testing.

Utility Help is Available

New Jersey's utility shutoff moratorium ended on March 15th. If you owe money on your utilities, here are three ways to get help: Call your utility company and ask about payment plans, Apply for assistance using the [DCAid Service Portal](#), Dial 2-1-1 for local services. You can apply for help now from multiple financial assistance programs using the [DCAid Service Portal](#) from New Jersey's Department of Community Affairs. With expanded income eligibility for some programs, you may be eligible for assistance even if you thought you were not. To arrange a payment plan, contact your utility company as soon as possible to enroll in a Deferred Payment Agreement to lower your monthly payment and keep your service on. Assistance for Homeowners Now Available

Public Comments Period to Open for NJ FamilyCare Medicaid Community

The [NJ FamilyCare Comprehensive Demonstration Renewal proposal](#) was submitted to the federal Centers for Medicare and Medicaid Services (CMS) on February 28, 2022. This demonstration, authorized under Section 1115 of the Social Security Act, governs the operations of significant components of **New Jersey's Medicaid program and Children's Health Insurance Program (CHIP)**. This demonstration is currently in its second five-year performance period, which is scheduled to expire on **June 30, 2022**.

Over 120 public comments were received on the initial draft proposal and numerous changes and clarifications to were made to the final proposal in response. A detailed summary of public comments and the responses begins on page 73 of the renewal proposal.

The renewal proposal is currently being reviewed for completeness by CMS and it will subsequently be posted on Medicaid.gov. At that time, the proposal will be open for a 30 day federal comment period. Stakeholders should submit any subsequent comments on the proposal through the federal comment process.

For each district, users can view ALICE data by race/ethnicity, and they can see a comparison between the percentage of households participating in SNAP and those who are below the ALICE Threshold. There is also a handy "Find your district" lookup.

The United For ALICE COVID-19 webpage has been updated to include a new Vaccination Tracker.
