A regularly scheduled meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 6 December 2018. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:13 p.m.

REPORTS

NEW JERSEY STATE POLICE

A Trooper of the Washington Township Barracks reported the following activity within Liberty Township for the month of November 2018;

COMMITTEEPERSON KARCHER

Mr. Karcher reported that over 78 children have enrolled in 2018-2019 basketball programs. Dan Grover volunteered to discuss gym access at the Liberty and Middle schools for recreational basketball practices with the school superintendent.

A 2019 Recreation Facility Application was received from the Great Meadows PTO. Mayor Inscho advised that all 2019 event reservations will be addressed 2019.

COMMITTEEPERSON GROVER

Mr. Grover reported that the Great Meadows Regional Board of Education will be facing a reduction of \$3.7 million in state aid over the next five years. Student enrollment has decreased from 1200 to 630 in the past decade. He encouraged the public to attend Board of Education meetings.

MAYOR INSCHO

Mayor Inscho reported concerns on the wall construction project along Lakeside Drive West. The Governing Body members agreed to consult with Ferriero Engineering if concrete work should continue in winter 2018-2019 or be delayed until spring 2019.

DEPARTMENT OF PUBLIC WORKS

A pre-printed report was received from the Department of Public Works for November 2018and placed on file.

MUNICIPAL TAX COLLECTOR

A pre-printed report was received from the Municipal Tax Collector for November 2018 and placed on file

UNFINISHED BUSINESS

SHARED SERVICE AGREEMENT FOR MUNICIPAL COURT

As per 1 November 2018 meeting, Mayor Inscho was awaiting additional information on the annual office operating expenses charged to Liberty Township and negotiations on the proposed annual 2% increase within the agreement. No communication has been received to date. A motion by Dan Grover authorizing Attorney Skoog to prepare a forward a letter to the Town of Belvidere requesting historical data for item #10 of the prior Agreement carried. "The Town of Belvidere agrees to provide Liberty Township with a statement of all costs and expenses incurred by the Town of Belvidere for the operation of the Shared Municipal Court".

BLOCK 52, LOT 42 – SUBSURFACE SEWAGE DISPOSAL SYSTEMS

Mayor Inscho reported that Erica Bush, Engineer, would be filing the paperwork with the Warren County Board of Health for the subsurface sewage disposal systems on Block 52, Lot 42 in January 2019.

NEW BUSINESS

BLOCK 15, LOT 7 – DEED OF RESTRICTION

Attorney Skoog reported that Annabelle Garganian is in the process of selling her property known as Hulse's Rest Home (Block 15, Lot 7). This property has a Deed of Restriction to comply with Liberty Township affordable housing obligations. Attorney Skoog and Attorney Schneider (Liberty Township LandUse Board Counsel) agree that the Deed of Restriction has a thirty year agreement and must be added to the new owner's deed. Attorney Skoog suggested that a means to report annual low income compliance be included in the new deed.

RESOLUTION #2018.074 RESOLUTION TO ADOPT PAY-TO-PLAY POLICY AND PROCEDURE

WHEREAS, the Township of Liberty, Warren County is a municipality incorporated within the State of New Jersey in the year 1926 and governed by five Committee-people that are elected by the members of the municipality at large; and

WHEREAS, the Township of Liberty, Warren County must comply with PL 2004, Chapter 19 (as amended by PL 2005, c 51) NJSA 19:44-20.4 et seq., known as the "New Jersey Local Unit Pay-to-Play" law; and

WHEREAS, the Township Committee believes that it is in the best interests of the municipality to accept an "Alternate" procedure, as defined in law, for the award of 2017 professional services contracts that are not publicly bid and may exceed \$17,500.00 annually or during the life of the contract; and

WHEREAS, the Township Committee believes that contracts for goods and services, from a single vendor, with a value greater than \$17,500.00 and less than the Local Public Bidding Threshold should be decided on a case-by-case basis; and

WHEREAS, the Township Committee requires contracts for goods and services, from a single vendor, except professional contracts, with a value greater than the Local Public Bidding Threshold will be bid according to the Local Public Bidding requirements.

BE IT RESOLVED That the Township Committee does hereby adopt the Pay-to-Play Policy and Procedures as the official purchasing policy for contracts covered under the above mentioned statutes.
