A regularly scheduled meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 1 February 2018. The meeting was opened by Mayor John Inscho with

Proposal #1 was Geese Chasers: Dog Chase for a 12 week program; addle eggs for an additional fee; and, Township must apply for a permit. Dog chasing has a limited effectiveness and does not provide long term management solutions. Cost \$90 per nest plus enrollment in dog chase program

Proposal #2 was Geese Police: A program that addles eggs; and, Township must apply for permit. Cost \$250 per nest.

Proposal #3 was USDA-APHIS: USDA will addle eggs and acquire all necessary permits. Cost up to \$2404.00. Mr. Karcher advised that the Recreation Commission is recommending approval of the contract with USDA-APHIS for nest identification and addling. Following lengthy discussion, it was agreed to revisit this issue at the 22 February workshop.

RECREATION FACILITY APPLICATIONS

#1 – A Recreation Facility Application was received from Great Meadows Cardinals for use of the baseball field from October 2017 through October 2018 for practice and games. The application was approved by the Recreation Commission at their 24 October 2017 meeting. It was agreed that the Great Meadows Cardinals may use Free Union fields for the remainder of 2017 on 9 November 2017 by the Township Committee. A motion by Mayor Inscho authorizing the Great Meadows Cardinals use of Free Union fields for the remainder of 2018 carried.

#2 – A Recreation Facility Application was received from the New Jersey DAWGS (Amateur Baseball Association). The application was approved by the Recreation Commission at their 30 January 2018 meeting. A motion by Mayor Inscho authorizing New Jersey DWAGS use Free Union fields for the 2018 season with reiteration of their responsibility for trash cleanup and building security carried. Should there be discrepancies the approval for use may be revoked.

GREAT MEADOWS REGIONAL SCHOOL DISTRICT

Mr. Grover reported on the following issues currently before the Great Meadows Regional Board of Education; Busing Hackettstown 7th/8th students to Great Meadows facilities; financial impact on student bussing to the GMRBOE budget; 2018 budget maximized at 2% cap with a declining enrollment; potential to close GMRBOW school facility; and, GMBOE unable to address issues at this time due to stressful conditions. The GMBOE has declined assistance with review of facility/student studies.

Mr. Grover advised that Governor Murphy has announced intentions to promote county wide schools.
