A regularly scheduled workshop of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 25 October 2018. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:08 p.m.

REPORTS

COMMITTEEPERSON GROVER

Mr. Grover presented information on the Great Meadows Regional Board of Education regarding the proposal on closing the Liberty School due to reduction of state aid from 8.7 million to 4.2 million. He stated that the Board of Education is projecting a savings of less than one-half million with the school closing. Previously the Mayors of Liberty and Independence Township had been invited to participate in the decision of school closure. The Mayors have now been removed from that decision making process. Mr. Grover stated that the GMRBOE student population has greatly reduced in the past five years.

NOTICE OF ROAD CLOSURE

All residents and visitors to the Mountain Lake area of Liberty Township should take notice that the portion of Lakeside Drive West from Block 52, Lot 39.04 (95 Lakeside Drive West) and Block 61, Lot 33 (144 Lakeside Drive West) shall be closed to access by all persons by any and all means, including but not limited to, by foot, bicycle, motor vehicle, or any other mode of transportation, except that those persons who reside in the closed area, along with their invitees, for the limited purpose of ingress and egress to their residence; those providing emergency services, or governmental services, be it a local, county, state and or federal entity, and all of those persons or entities who are actually working or providing services to the construction site.

This road closure shall remain in effect until rescinded by subsequent resolution of the Township of Liberty.
