## MOUNTAIN LAKE HAB (HARMFUL ALGAE BLOOM)

Notification was received from Warren County Board of Health on 22 November 2019 that Harmful Algae Bloom (HAB) was tested and confirmed within Mountain Lake. Warren County posted the following advisory around Mountain Lake for public information; Danger/High Risk – no contact and ingestion (humans and animals). A confirmed Harmful Algal Bloom is present with levels qualifies at or above the NJ Health Advisory Guidance. There should be no contact with the water including, but not limited to, swimming, wading, and watersports. Fish caught in this waterbody should not be eaten. Pets and livestock should not contact or ingest the water. Warren County will conduct a repeat sampling in December and advice of the results.

# NJ TREE RECOVERY CAMPAIGN

A New Jersey Tree Recovery Campaign Community Application 2019 was received from the Environmental Commission for the receipt of 500 free trees to be distributed on 2 May 2020 in partnership with the local Girl Scout Troop 97260 at the John R Fisher Pavilion to municipal residents.
