## COVID19 DECLARATION EXTENSION PROCLAMATION OF STATE OF EMERGENCY TO ALL CITIZENS AND PERSONS WITHIN THE TOWNSHIP OF LIBERTY AND TO ALL DEPARTMENTS, DIVISIONS AND BUREAUS OF THE MUNCIIAPL GOVERNMENT OF THE TOWNSHIP OF LIBERTY

WHEREAS, pursuant to the powers vested in me by Chapter 251 of the laws of 1942, as amended and supplemented, NJSA. App. A;9-30 et. seq.; NJSA 40:48-1 (6), and ordinances enacted pursuant thereto; NJSA 2 C:33-1 et. seq.;--whichever law or laws apply), Executive Order 103 and by ordinances adopted by the Township of Liberty I have declared that a STATE OF EMERGENCY exists within the Township of Liberty; and

WHEREAS, the aforesaid laws authorize the promulgation of such orders, rules, and regulations as are necessary to meet the various problems which have or may be presented by such an emergency; and

WHEREAS, by reason of the rapidly evolving outbreak of the novel coronavirus, COVId-19, the need for government operations to address staffing capabilities to ensure essential operational needs are met in order to mitigate factors which may further adversely affect the health, safety, and welfare of the people of the township of Liberty and exacerbate and worsen existing conditions; and

WHEREAS, it has been determined that these areas of the Township of Liberty should be declared disaster areas, and further that certain measures must be taken to ensure that the authorities will be unhampered in their efforts to maintain law and order as well as an orderly flow of traffic and further in order to protect the persons and property of the residents affected by the conditions and finally that governmental operations including but not limited to the conduct of public meetings shall be substantially altered; and

WHEREAS, all lands within the boundaries of the Township of Liberty are hereby designated as disaster areas.

NOW, THEREFORE, IN ACCORDANCE with the aforesaid laws, we do hereby promulgate and declare the following regulations attached hereto and made a part of hereof shall be in addition to all other laws of the State of New Jersey and the Township of Liberty.

#### MOUNTAIN LAKE BEACH AD HOC LAKE STUDY GROUP

Mayor Inscho reported that the Ad Hoc Lake Study Group met on Monday, 29 June. Discussion ensued on a second HAB testing from the beach area, development of a water monitoring plan, and NJ State Lake Programs. A motion by David Rogers authorizing Dan Kurela (Environmental Commission Representative) to collect Mountain Lake water at the beach access and deliver this collected water to Garden State Labs for HAB testing carried.

# MOUNTAIN LAKE BEACH

John Ward, Recreation Assistant, reported that he has received 5-6 lifeguard applications to date. Consideration of limitations for lifeguard work hours based upon age; hours of operation; COVID-19 plan and restrictions; no beverages/snacks will be available for public sale; and, beach opening will be dependent upon second acceptable consecutive HAB test results.

# DANVILLE MOUNTAIN PAVING

Mayor Inscho reported that he had not received three responses from vendors on the partial paving of Danville Mountain within the past week and this topic would be addressed at the 6 August 2020 meeting of the Township Committee for consideration of award. The project will include three (3) inches of pavement, retain the crown in the road and Liberty Township would be purchasing the material.

#### ORDINANCE 2020-003

CAPITAL ORDINANCE PROVIDING FOR ROAD IMPROVEMENTS IN THE TOWNSHIP OF LIBERTY, COUNTY OF WARREN, STATE OF NEW JERSEY APPROPRIATING THE AMOUNT OF \$24,803.01 FROM THE CAPITAL FUND BALANCE.

BE IT ORDAINED by the Township Committee of the Township of Liberty, in the County of Warren, State of New Jersey as follows:

Section 1. The Township of Liberty, in the County of Warren, New Jersey (the "Township") hereby appropriates \$24,803.01, fully funded by the General Capital Fund, for the acquisition of road improvements in the Township of Liberty.

Section 2. The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, is on file in the office of the Clerk and is available for public inspection.

Section 3. The ordinance shall take effect after final adoption and publication and otherwise as provided by law.
