# INTRODUCTION OF MUNICIPAL BUDGET 2020

A motion by Mike Beyer to adopt the following Resolution carried.

Resolution #2020.030 Self-Examination of Budget

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on 11 February 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of Liberty has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township meets the necessary conditions to participate in the program for the 2011 budget year.

*BE IT RESOLVED* By the Township Committee of the Township of Liberty that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the Township Committee has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:

- a. All estimates of revenue are reasonable, accurate and correctly stated,
- b. Items of appropriation are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED That a copy of this Resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Mayor Inscho stated that the Liberty Township Municipal Budget would see a slight increase to a total of 2,045,375.0. The proposed 2020 budget includes funding for road improvements, Liberty Lake Dam decommissioning, municipal complex paving and additional projects. A motion by Mayor Inscho to introduce the 2020 Municipal Budget carried. The budget will be published 13 March 2020 and scheduled for public hearing and considered of adoption on 2 April 2020.

### ORDINANCE #2020.002

AN ORDINANCE OF THE TOWNSHIP LIBERTY, NEW JERSEY - GOVERNING BODY REQUIRE LARGE HARDENED BUILDINGS TO INSTALL RADIO BOOSTER EQUIPMENT TO SUPPORT INTERIOR RADIO COMMUNICATIONS WITH LAW ENFORCEMENT OFFICERS, FIREFIGHTER AND EMERGENCY MEDICAL PERSONNEL (EMERGENCY FIRST RESPONDERS)

WHEN RADIO COMMUNICATIONS DIFICIENCIES EXIST

WHEREAS, in emergency situations, including natural and manmade disasters, it is essential that radio communications, which will insure access to emergency services personnel including police, fire, emergency medical service and other first responders, be maintained in all locations within the community; and

WHEREAS, of particular importance is to require that such communications be available to and from "large hardened buildings", including malls, office and retail centers, hotel, condominiums and apartments, medical facilities and training centers; and

WHEREAS, the Liberty Township Governing Body finds that it is essential that an Ordinance requiring large hardened buildings to install radio communications equipment which will insure access to emergency services personnel including police, fire, emergency medical service, and other first responders be enacted.

NOW, THERFORE, BE IT ORDAINED by the Governing Body of the Township of Liberty, Warren County, New Jersey as follows;

The findings, conclusions, and statements of fact contained in the foregoing preamble are hereby adopted, ratified, and incorporated herein as specified in the attached "In-Building Radio Communications Specifications".
