Mayor Inscho asked for a moment of silence for the mass causalities these last few days.

## **REPORTS**

COMMITTEEPERSON SPANGENBERG Mr. Spangenberg reported that 118 registrations have been received for spring soccer.

## COMMITTEEPERSON ROGERS

Mr. Rogers reported that a NJDEP Lakes Management Grant was filed for permeable paving around the lake. It is suggested that the DPW 2023 budget consider funding for vortex screens and drains.

## COMMITTEEPERSON GROVER

Mr. Grover reported that the LandUse Board had reviewed the proposed Solar Ordinance.

GREAT MEADOWS BOARD OF EDUCATION – Amber Gratacos reported that GMRBOE budget has been adopted. The new health standards curriculum will be introduced to the staff and parents prior to the start of the school year to review controversial topics.

## DEPARTMENT OF PUBLIC WORKS

Mayor Inscho reported that the Bomford mower was being installed on the tractor and would be available on Monday, 6 June to begin roadside mowing.

#### RECREATION

Discussion ensued on the absence of lifeguard certification documentation and the current HAB status of "advisory" within Mountain Lake. It was stated that consideration of lifeguard staffing may be addressed at the 23 June meeting.

ORDINANCE #2022.003 - PUBLIC HEARING – Public hearing on Ordinance #2022.004 continued. Comments were received from Autumn M Sylvester, Planner for Liberty Township LandUse Board, Jess Symonds, Engineer for Liberty Township LandUse Board and Richard Wenner, Liberty Township Municipal Attorney. Following discussion, a motion by Mayor Inscho to create a sub-committee consisting of the Municipal Planner, Municipal Attorney, 2 members of the LandUse Board, Deputy Mayor Grover and Committeeperson Rogers to review the proposed solar ordinance carried.

## DETENTION/RETENTION PONDS

Rachel Bernard, owner of Block 5, Lot 21.14, which contains a detention basin, came before the Governing Body stating that she never received a letter and asking that the Township continue to maintain the detention basin. Attorney Moscagiuri advised that he and Attorney Wenner would research Ms. Bernard's deed for easement language and report on the division of detention basin responsibility. She was advised that ultimately it is private property and the basin maintenance is her responsibility. Mayor Inscho and the DPW Supervisor will visit the site.

## DAM SAFETY INSPECTION REPORT FOR LIBERTY LAKE DAM

Mayor Inscho reported that Beth Styler Berry of The Nature Conservancy is working with Liberty Township to investigate Federal Grant financial resources for dam removal.

DPW Supervisor reported that on 23 June a vendor is coming to provide an estimate on cost and scheduling.

## ORDINANCE #2022.004 – CAPITAL IMPROVEMENTS

# CAPITAL ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS IN THE TOWNSHIP OF LIBERTY, COUNTY OF WARREN, STATE OF NEW JERSEY APPROPRIATING THE AMOUNT OF \$30,900.00 FROM THE CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED by the Township Committee of the Township of Liberty, in the County of Warren, State of New Jersey as follows:

Section 1. The Township of Liberty, in the County of Warren, New Jersey (the "Township") hereby appropriates \$30,900.00, fully funded by the Capital Improvement Fund, for the acquisition of various general capital improvements including, but not limiting to, road equipment and information technology in the Township of Liberty.

Section 2. The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, is on file in the office of the Clerk and is available for public inspection.

Section 3. The ordinance shall take effect after final adoption and publication and otherwise as provided by law.
