COMMITTEEPERSON SPANGENBERG

Mr. Spangenberg reported that the spring soccer program had 155 children from Liberty and Independence Township enrolled.

MAYOR INSCHO

Mayor Inscho reported on need for Mountain Lake sub-committee meeting to discuss option in controlling "root pop".

GREAT MEADOWS BOARD OF EDUCATION – Amber Gratacos reported that GMRBOE budget has received reduced State funding which will result in the reduction of 8 teaching staff and the average middle school class size will increase to 37 students. The 2022-2023 budget increase would be approximately \$135 per quarter for the \$300,000 assessed residence. Discussion ensued on Parental Bill of Rights. John Inscho made a motion supporting the County Commissioner Support for Parental Bill Rights

ASSIGNMENT OF MUNICIPAL TAX LIENS

Attorney Wenner reported that he had contacted the party interested in acquiring the Municipal Tax Lien on Block 46, Lot 15. He would have a Resolution authorizing assignment at the 2 June 2022 meeting for consideration of adoption by the Governing Body.

ORDINANCE #2022.003 - PUBLIC HEARING - A motion by Dan Grover to open public hearing carried. The Liberty Township LandUse Board requested that the solar ordinance be deferred so the Planner could formulate a response with feedback and comments from the Liberty Township LandUse Board meeting of 27 May 2022. Public hearing carried to 2 June 2022.
