A regularly scheduled meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 1 June 2023. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:05 p.m.

REPORTS

COMMITTEEPERSON ROGERS – Mr. Rogers reported that the Mountain Lake subcommittee met yesterday to discuss the lake temperature, weed harvesting, herbicide treatments, HAB, public/private ownership and the use of drones to monitor lily pad/milfoil growth.

MAYOR INSCHO - Mayor Inscho stated that asphalt was placed on Danville Mountain and Rader Road.

ENVIRONMENTAL

A pre-printed report was received from the Environmental Commission for May 2023 and placed on file. Larry Supp, Environmental Commission Chairperson, presented the consideration of weed harvesting vs dredging within Mountain Lake. He stated that an ANJEC Grant for \$1500 to be applied toward weed harvesting was denied. He presented photos from 2023 exemplifying the weed harvesting opening toward the outlet. Following conversation, a motion by Dave Rogers to adopt the following Resolution carried.

RESOLUTION #2023.050 AWARD OF CONTRACT

WHEREAS, N.J.S.A. 40A: 5-4 requires the Governing Body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2022 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6 and a copy has been received by each member of the Governing Body; and

WHEREAS, R.S. 52:2788-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 50:30-6.5, a regulation requiring that the Governing Body of each municipality shall, by Resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

WHEREAS, the members of the Governing Body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the Governing Body attached hereto; and

WHEREAS, such Resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the Governing Body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local Governing Body to the penalty provisions of R.S. 52:27BB-52 to wit:

"R.S. 52:27BB-52. A local officer or member of a local Governing Body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon convictions, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office".

AUTHORIZING THE SOLICITATION OF BIDS FOR THE PURCHASE OF TOWNSHIP OF LIBERTY HELD TAX SALE CERTIFICATES ON VARIOUS PROPERTIES FOR LESS THAN FACE VALUE

WHEREAS, the Township of Liberty is the holder of numerous Tax Sale Certificates in varying amounts; and

WHEREAS, Pursuant to NJSA 54:5-114.1 or NJSA 54:5-114.2 it may sell the certificate at a public sale upon authorization and the appropriate written notice to the property owners and public, and posting of said notice and publications as required by statute; and

WHEREAS, NJSA 54:5-114.2(b) authorizes the Township of Liberty to accept bids for the purchase of the tax sale certificates listed on Exhibit A for less than the total amount due, together with interest and cost on the certificates; now therefore

WHEREAS, the Tax Collector is requesting authorization to solicit bids for the purchase of the tax sale certificates listed in Exhibit A for less than the total amount due, together with interest and cost on the certificates; now therefore

BE IT RESOLVED, by the Governing Body of the Township of Liberty, that:

- 1. The Township-held tax sale certificates shall be sold by means of bids. The Township authorizes the posting of public notice and the solicitation of bids for the purchase of the tax sale certificates listed in Exhibit A hereof
- 2. The Tax Collector is hereby authorized to solicit the aforesaid bids for the purchase of the tax sale certificates listed in Exhibit A hereto
- 3. The municipality will receive bids for such certificate of tax sale and subsequent municipal liens, even though such bids be less than the total amount due on such certificate of sale including all subsequent liens plus interest and costs.
- 4. The sale shall be held at a regular meeting of the Governing Body to be held on 5 October 2023 at 6:00 pm which date shall accommodate the statutory required notices, including those set forth in paragraph 6

5. The Township shall advertise the sale pursuant to NJSA 54:4-114.2(b) by public notice in the Express Times once in the week preceding the calendar week of the regular Governing Boyd meeting at which meeting such bids will be passed on. The advertisement shall include the exact time and place of such regular meeting.

- 6. The Mayor and Governing Body reserve the right to reject all bids
- 7. The public sale shall be conducted in accordance with the procedures to be announced by the Municipal Clerk
- 8. The Governing Body may accept or reject any bids at the regular meeting designated for the passing on such bids
- 9. Upon payment of the sale amount, each tax sale certificate shall be assigned to the accepted bidder without representation or warranty.
