REPORTS

ENVIRONMENTAL

A pre-printed report was received from the Environmental Commission for July 2023 and placed on file.

- * Failure of Solitude to perform contract herbicide treatment at the beach.
- * Request to be removed as administrators for budgeting and administration of herbicide treatment and weed harvesting.
- * Program of weed removal at beach in July 2023
- * Goal to phase out cesspools that are still in use within Liberty Township upon transfer of home ownership by enacting an ordinance that tightens up the state law and certain exceptions listed

RECREATION

A pre-printed report was received from the Recreation Commission for July 2023 and placed on file.

MUNICIPAL TAX COLLECTOR

A pre-printed report was received from the Municipal Tax Collector for July 2023 and placed on file

COMMITTEEPERSON ROGERS

Mr. Rogers reported that the Mountain Lake Community Association received a \$80,000 grant. The grant will be used to contract with Princeton Hydro for the creation of a Lake Management Plan. Volunteers continue to collect bi-weekly samples monitoring HAB at an estimated in-kind value of \$20,000.

COMMITTEEPERSON GROVER

Mr. Grover stated that the LandUse Board has finalized a climate change resilience strategy and continues to update the Master Plan. The LandUse Board is working on a soils Ordinance for consideration in 2023

MAYOR INSCHO

Mayor Inscho thanked Wayne Spangenberg, Pete Karcher, the DPW and Mountain Lake Fire Company for their assistance during the 14 July Weather Event with flooding and pumping. Mayor announced the employment of two new DPW staff members.
