CASA SHaW PROCLAMATION

WHEREAS, the Liberty Township, in Warren County, New Jersey recognizes the problem of child abuse and neglect and is committed to helping its victims; and

WHEREAS, Court Appointed Special Advocates (CASA) of Somerset, Hunterdon and Warren Counties recruits, screes trains, supports and supervises community volunteers as advocates for children who have been removed for their homes due to neglect and abuse; and

WHEREAS, adverse childhood experiences and trauma, such as those caused by child abuse or neglect, can have long-lasting effects on a child's health, wellbeing and success; and

WHEREAS, survivors of child abuse need people in their lives that will consider their best interests; and

WHEREAS, the Court Appointed Special Advocate programs have a record of public service, helping protect the safety and wellbeing of (town) abused and neglected children; and

WHEREAS, Court Appointed Special Advocates (CASAs) are assigned by family court judges to champion the needs of child abuse victims; and

WHEREAS, CASAs are everyday people, with diverse backgrounds and professions, that go through very specialized training to be a volunteer voice for children in the child welfare system; and

WHEREAS, CASAs volunteers serve as the court's eyes and ears in a child's life, helping to improve the quality of information presented to the court and child welfare systems; and

WHEREAS, April 2023 is National Child Abuse Prevention and Awareness Month, an observance that reflects the purpose of CASA programs;

ORDINANCE #2024.003 - Following discussion, a motion by Wayne Spangenberg to introduce Ordinance #2024.003 on First Reading carried. Public Hearing and Adoption are scheduled for 4 April 2024.

ORDINANCE #2024.003

ORDINANCE OF THE TOWNSHIP OF LIBERTY, COUNTY OF WARREN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING ARTICLE III ENTITLED "PARKING, STANDING, AND STOPPING" OF CHAPTER 100 – VEHICLES AND TRAFFIC – TO CREATE CHAPTER 100-22.2 ENTITLED "PLACING SNOW ON PLOWED ROADS PROHIBITED" TO PROHIBIT THE PLACING OF SNOW ON PLOWED ROADS DURING SNOWFALL

WHEREAS, the Township Committee of the Township of Liberty wishes to implement certain requirements on the Township's residents during the periods of snowfall; and

WHEREAS, these requirements will prohibit the throwing, shoveling, pushing, or blowing of snow from a resident's driveway onto the main portions of the roads plowed by the Township Department of Public Works; and

WHEREAS, the prohibition on throwing, shoveling, pushing, or blowing of snow onto roads plowed by the Township crew is beneficial to the Township and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Liberty, County of Warren, State of New Jersey that Article III "Parking, Standing, and Stopping" of Chapter 100 – Vehicles and Traffic – be amended to create Chapter 100-22.2 entitled "Placing Snow on Plowed Roads Prohibited" as follows:

SECTION I:

§ 100-22.2. Placing Snow on Plowed Roads Prohibited.

During the periods of snowfall, no person shall throw, shovel, push or blow snow from a driveway onto the main portions of the roads plowed by the Township Department of Public Works. Any person violating the provisions of this Section shall, upon conviction thereof, be subject to the following fee schedule:

First Offense: – Warning Letter;

Second Offense: – One Hundred Dollar (\$100.00) Fine; Third Offense: – Five Hundred Dollar (\$500.00) Fine.

SECTION II:

All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent necessary to remedy the inconsistency.

SECTION III:

In the event any section, paragraph, subdivision, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall only apply to that section, paragraph, subdivision, clause, or provision so adjudged, and the remainder of this Ordinance shall be deemed to be valid and effective.

SECTION IV:

This Ordinance shall take effect immediately upon its final passage and publication as provided by law.
