Joe Peters – Mr. Peters advised the Governing Body that as the purchaser of the tax lien on 164 Lakeside Drive West, he wanted to be completely transparent that he has tree removal and demolition of the structure scheduled once the property is 100% within his name.

Lisa Thomas – Ms. Thomas questioned the appointment of a Municipal Engineer. Mayor stated that this discussion would be carried to 25 April workshop.
