A regularly scheduled meeting of the Township of Liberty was held in the Municipal Building, 349 Mountain Lake Road, Great Meadows on 7 October 2021. The meeting was opened by Mayor John Inscho with Adequate Notice of Meeting and the Pledge of Allegiance at 7:05 p.m.

REPORTS

COMMITTEEPERSON SPANGENBERG

Mr Spangenberg reported that Community Day was a success. The soccer and basketball programs are going well. He stated that the Recreation Commission was requesting a credit card for purchases.

COMMITTEEPERSON GROVER

Mr Grover reported that there had been a Great Meadows Regional Board of Education meeting earlier this evening. They meet the new School Board members and Superintendent.

MAYOR INSCHO

Mayor Inscho stated that the DPW is preparing winter plows and spreaders. The Bomford roadside mower is no longer operational and replacement quotes are being collected. The Mayor had spoken with Senator Steven Oroho regarding Liberty Township's eligibility for lake funding. An application process has not been established to date.

GREAT MEADOWS REGIONAL BOARD OF EDUCAITON

Heather Wulf reported that there are three (3) vacant Independence seat on the Board of Education. The Board has conducted interviews to fulfill 2 seats and the third will be filled by the County Superintendent. Board of Education meeting is 28 October.

MUNICIPAL TAX COLLECTOR

A pre-printed report was received from the Municipal Tax Collector for September 2021 and placed on file

APPROVAL OF MINUTES

A motion by Wayne Spangenberg to adopt the public and executive session minutes of 9 September 2021 carried.

UNFINISHED BUSINESS

MOUNTAIN LAKE WEED HARVESTING

Bob Ballou, President of Mountain Lake Community Association, stated that the weed harvesting program would be ready to go later in October but no definite dates have been set. He also stated that the farmer who accepted the lake debris would not provide a written letter of acceptance with release of the municipality. A motion by Wayne Spangenberg authorizing Mayor Inscho to execute the weed harvesting contract with Aquatic Analysts for a municipal cost not to exceed \$10,000, upon legal amendment by Attorney Skoog carried.

PIX4D SOFTWARE

Discussion pursued on the acquisition of the PIX4D Software for Mountain Lake monitoring by the Lake Association. A motion by Wayne Spangenberg authorizing the acquisition of the PIX4D software at the cost of \$390 carried.

NEW BUSINESS

PAVILION RESERVATION REQUESTS

#1 – A pavilion reservation request form was received from Skylands Unitarian Universalist Fellowship for Sunday, 17 October 2021 at 9:30 am to 12:30 pm for a church service and lunch. All fee and escrow monies were posted.

WARREN COUNTY ALLIANCE PROGRAM JULY 2021-JUNE 2022

RETENTION/DETENTION POND MAINTENANCE

Discussion ensued on the maintenance of retention/detention ponds located within Liberty Township. It was agreed to investigate the Developer Agreements for each of the ponds to determine maintenance responsibility.

MOUNTIAN LAKE PORCUPINE CRIBS

It was reported that 18 porcupine cribs have been assembled and NJ Fish and Game has intentions to install them in Mountain Lake next week. Mayor stated that the DPW would determine the location for concrete block storage and the DPW front end loader may be needed on 19 October for installation.
